

Request to fund a regulated qualification

NCFE Level 2 Certificate in Artificial Intelligence (AI) for the Workplace | Qualification number 610/7672/7

What it is

A regulated qualification awarded by NCFE, an awarding organisation recognised by Ofqual, sitting on the Regulated Qualifications Framework at Level 2. Not a certificate of attendance issued by a training company: the award is issued and recorded by the awarding organisation, so it is verifiable by anyone, including a future employer.

- Data and AI systems (15 guided learning hours)
- Ethical and responsible use of AI in the workplace (15 guided learning hours)
- Human oversight when working with AI systems (20 guided learning hours)

What it asks of the business

Time. Study is self-paced and online, so it fits around the working week rather than removing someone from it. There is no day release and no travel.

Evidence, where the qualification is portfolio assessed. The evidence is drawn from work the learner is already doing, which means the assessment produces a written record of competence the business can also use.

Money. £395, invoiced to the employer. We can raise a purchase order against your own reference.
